 "obscene and patently offensive" as those terms are defined in Tenn. Code Ann. § 55-8-187
 and under relevant First Amendment jurisprudence.
- Metro will file a voluntary nonsuit of Traffic Court Ticket No. K-535142 in the General Sessions Court of Nashville and Davidson County.
- Plaintiff waives any claims related to the issuance of Traffic Court Ticket No. K-535142
 against the Metropolitan Government or its employees.
- 4. A declaratory judgment that Plaintiff's bumper sticker is protected by the First Amendment to the U.S. Constitution shall issue.
- All remaining claims that were brought in this litigation should be dismissed pursuant to Tenn. R. Civ. P. 41.01. The parties shall bear their own costs incurred in bringing and defending this case.

It is therefore **ORDERED** the lawsuit is dismissed pursuant to Tenn. R. Civ. P. 41.01. This constitutes a final order in this action. Defendant shall bear the court costs incurred in this action, for which execution may issue if necessary.
