The Defendants make no admission of liability regarding any such claims.

4. This award of attorney's fees resolves all outstanding claims in this matter. Taken together, this Order and the Memorandum and Rule 54.02 Final Order on Motions Argued 8/5/22 constitute a final judgment on the merits pursuant to Tenn. R. Civ. P. 58. The court costs of this action are taxed against the Defendants, for which execution shall issue if necessary. The Parties waive all rights of appeal.
